

## WEATHER UNION - TERMS AND CONDITIONS

THESE T&Cs WILL GOVERN YOUR USE OF UNION WEATHER, PLEASE ENSURE THAT YOU READ AND UNDERSTAND THESE T&Cs BEFORE USING THE WEATHER UNION.

By clicking the “**I ACCEPT**” button, you agree to be bound by these Weather Union Terms and Conditions (“**T&Cs**”) for using and accessing Weather Union for the purpose of accessing weather related information and updates across different cities and states in India. These T&Cs shall form the complete understanding between you and Zomato.

If for any reason you do not accept the terms contained in these T&Cs, do not proceed to use the Weather Union or avail any of the Zomato Services being provided therein.

“**Applicable Law(s)**” shall mean and include any law, statute, ordinance, rule, regulation, guideline, policy, or other pronouncement having the effect of a law in India, is in effect or which may come into effect on a future date.

“**Intellectual Property Rights**” shall mean and include the copyright (*whether registered or not*), patents including rights of filing patents, trademarks, trade names, trade dresses, collective marks, associate marks and the right to register them, designs (*both industrial and layout*), geographical indicators, moral rights, broadcasting rights, displaying rights, distribution rights, selling rights, reproducing rights, domain names, internet address, graphics, artwork, links, information, logos, software, configuration, marketing and distribution material and any other intellectual property right in the Weather Union, which are used and/or owned by Zomato from time to time;

“**Service Recipient**” or “**you**” or “**your**” or “**yourself**” shall mean such person using the Weather Union to avail Zomato Services.

“**Policies**” shall mean the policies and guidelines as may be available in the help section of the Weather Union.

“**Zomato**” or “**we**” or “**us**” or “**our**” shall mean Zomato Limited and include all our successors, affiliates and assigns.

“Weather Union” means the Live Weather Platform which is a website and/or mobile application (if applicable) developed by Zomato showcasing data relating to weather, and/or integrating with Zomato’s weather API (application programming interface) to receive weather related information and updates across different states and cities in India.

### 1. INTERPRETATION

Unless the context of these T&Cs otherwise requires:

A word or an expression, which denotes a natural person shall include an artificial person (*and vice versa*), any one gender shall include the other genders, the singular shall include the plural (*and vice versa*).

- (i) Heading and bold typeface in these T&Cs are for convenience only and shall be ignored for the purposes of interpretation.
- (ii) The use of the word “including” followed by a specific example(s) in these T&Cs, shall not be

construed as limiting the meaning of the general wording preceding it.

- (iii) The rule of construction, if any, that a contract should be interpreted against the parties responsible for drafting and preparation thereof, shall not apply.
- (iv) Reference to any Applicable Law(s) shall mean a reference to that law as amended, consolidated, supplemented, or replaced.

## **2. REGISTRATION**

- (i) You shall be required to register on Weather Union by providing such details as requested on the Weather Union. You agree and accept that as on the date of your registration on Weather Union, the information provided by you are yours and not of any other person or entity and such information is complete, accurate and up-to-date.
- (ii) You acknowledge and accept that Zomato shall undertake such steps to verify such information as submitted by you on Weather Union. If you provide any information that is untrue, inaccurate, obsolete or incomplete, or Zomato has reasonable grounds to suspect that such information is untrue, inaccurate, obsolete or incomplete, Zomato reserves the right to suspend or terminate your Account post which you will not be able to avail the Zomato Services until information related to your account is verified.
- (iii) In case you wish to update any information on Weather Union, you may update the same by following the process as may be provided on Weather Union or reach out to our customer support.
- (iv) You will be responsible for maintaining the confidentiality of the account information and shall be fully responsible for all activities that occur under your account. You agree to immediately notify Zomato of any unauthorized use of your account information or any other breach of security. Zomato cannot and will not be liable for any loss or damage arising from your failure to comply with this clause. You may be held liable for losses incurred by Zomato or any other visitor to Weather Union due to authorized or unauthorized use of your account as a result of your failure in keeping your account information secure and confidential. Use of another Service Recipient's account information for using Weather Union is expressly prohibited.

## **3. SERVICES**

- (i) You hereby agree that Zomato is providing weather and related forecasts, information and updates available on Weather Union along with other services that may be developed by Zomato from time to time on Weather Union ("**Zomato Services**").
- (ii) You hereby agree that the Zomato Services are being provided to help you in checking the weather forecasts around different cities and states in India and you may use the same to (i) download any information related to weather for such time period as available on Weather Union; and (ii) integrate your API with the API keys as may be provided on Weather Union.
- (iii) Zomato shall use your location-based information that is captured by Zomato through a global positioning system when you are using your personal computer or mobile device in order for Zomato to provide Zomato Service through Weather Union. Such location-based information shall be used by Zomato to provide and improve the Zomato Services being offered to you. You acknowledge and hereby consent to the monitoring and tracking of your geo-location information.
- (iv) Weather Union and Zomato Services are only available in relation to the weather information in India and the Service Recipient shall not access or use Weather Union from any other jurisdiction except for India. If a Service Recipient accesses or uses Weather Union from any other jurisdiction except for India, the Service Recipient shall be liable to comply with all Applicable Laws and

Zomato shall not be liable for the same, whatsoever.

- (v) Zomato hereby agrees and acknowledges that the historical climate data information made available under the weather facts section is taken from the publicly available data provided by the India Meteorological Department, Ministry of Earth Sciences, Government Of India as more specifically available on <https://mausam.imd.gov.in> (“**IMD Data**”). Zomato hereby acknowledges that the historical climate data information provided herein is for informative purposes only and the India Meteorological Department is the sole owner of the IMD Data which is being used by Zomato. Any data other than the historical climate data information available under the weather facts section belongs to Zomato.
- (vi) Zomato hereby agrees and acknowledges that the interactive map of India used on Weather Union is following the guidelines which are publicly made available by Survey of India, Department of Science & Technology, Government Of India, as more specifically available on <https://www.surveyofindia.gov.in/>.
- (vii) The availability and access to free API's for each profile in relation to the Zomato Services shall be valid for a maximum of 60,000 API's in a particular financial year. In case You require access to any additional API, then You should reach out to [info@weatherunion.com](mailto:info@weatherunion.com) for such requests.

#### **4. OBLIGATIONS OF THE SERVICE RECIPIENT**

- (i) You shall comply with all Applicable Laws, bye-laws and regulations of local and statutory authorities having jurisdiction over you relating to these T&Cs, and shall be solely responsible for obtaining and maintaining all necessary licenses applicable to your business.
- (ii) You shall provide complete and accurate details for the purposes of registering on Weather Union and thereof availing the Zomato Services.
- (iii) You understand and represent that Zomato shall not in any manner be held liable or responsible for any defect in the Zomato Services.
- (iv) You shall only use the Zomato Services and/or any other information which you may receive from Weather Union for the purposes of accessing weather related information and you agree that no information received through Weather Union shall be utilized for any purpose other than as agreed under these T&C's.
- (v) You agree that you shall use Zomato Services for lawful purposes only and for such purposes as permitted on Weather Union. You shall be solely liable and responsible for any liability that is imposed on Zomato in this regard and shall keep Zomato indemnified to such extent.
- (vi) You agree that if it is brought to the knowledge of Zomato through any law enforcement authority or any other third-party that you have used Zomato Services for any unlawful activities, Zomato may at its sole discretion take appropriate actions including suspension or termination of your account and Zomato Services. Zomato may also, on a request received from the law enforcement authorities, provide your details as may be requested, which may include details of your company/organization, your personal details, etc. to such authorities.
- (vii) You shall be responsible for, connecting to, accessing or otherwise using the Zomato Services according to the interface requirements as may be communicated by Zomato from time to time. You shall obtain and maintain all appropriate equipment at your own cost as may be required to connect, access or otherwise use the Zomato Services including, without limitation, hardware, servers, software, operating systems, networking, web servers.
- (viii) You shall be responsible for handling any such issues and/or errors which you may incur from

using the Zomato Services.

- (ix) You agree that Zomato shall not be held liable and/or responsible for any loss or damage which may be incurred by you for using the Zomato Services.
- (x) You shall provide all the necessary information and assistance to Zomato to enable Zomato to perform Zomato Services in accordance with these T&Cs.
- (xi) You hereby agree that in case you opt for hosting weather equipment at Your address (“Location”) then such equipment shall be used for weather and climate forecast (“Device”) and accordingly, You hereby agree:
  - that no hindrance is caused to Zomato due to any reason whatsoever during the installation of the Device at the Location and thereafter in operating the Device.
  - to keep the Device protected and further ensure that the Device installed at the Location is not damaged, uninstalled and/or harmed in any way.
  - that a minimum distance as required and intimate by Zomato is maintained between the Device and any other structure/device installed at the Location.
  - to inform Zomato at least sixty (60) days prior to the change in any ownership/usage rights of the Location where the Device is installed. Further, if there is any change in the Location of the installation of the Device then the same shall be intimated at least fifteen (15) days prior to Zomato.
  - that if any damage is caused to the Device, then You will be bound to inform Zomato on an immediate basis or within a maximum duration of twenty-four (24) hours upon the occurrence of such instance.
  - that You will not hack the Device to get access to the data. Zomato reserves the right to take appropriate legal action against You in such cases.
  - that You allow Zomato to access the Location where Device is installed for servicing and maintenance of the Device, which will happen twice a year. You will not cause any hindrance or blockage for Zomato for such servicing and maintenance.
  - that Zomato shall always be the sole and lawful owner of the Device and You will not have any rights, claims and/or lien whatsoever on the said Device under any circumstances whatsoever.

## **5. SERVICE RECIPIENT INFORMATION**

- (i) You hereby agree that Zomato collects, stores, accesses, uses and processes your information in accordance with its privacy policy i.e. <https://www.weatherunion.com/privacy/>.
- (ii) You hereby agree that Zomato shall not be responsible in any manner whatsoever for the authenticity of the personal information or supplied by you to Zomato.

## **6. INTELLECTUAL PROPERTY RIGHTS**

- (i) You hereby agree that all Intellectual Property Rights shall be in absolute ownership, possession, and control of Zomato, and you are only permitted to use such Intellectual Property Rights in connection with the Zomato Services availed pursuant to these T&Cs. It is hereby clarified that

no license or rights are granted in the Intellectual Property Rights to you under these T&Cs, by implication or otherwise.

- (ii) The Zomato Services are provided through Weather Union which is a proprietary software/mobile application developed and made available exclusively by Zomato. Zomato is the sole owner of Weather Union and accordingly, Zomato only provides you with a single limited license to download, use and access Weather Unions on your devices for the limited purpose of using the Zomato Services. All content on Weather Union, including but not limited to, designs, text, graphics, images, video, information, logos, button icons, software, audio files and any other content (“**Content**”) are the exclusive and sole property of Zomato. You may not copy, reproduce or use such Content whatsoever. All icons and logos are trademarks of and proprietary to Zomato and any unauthorized copying, modification, use or publication of these marks is strictly prohibited. Nothing in these T&C’s will be considered to constitute a transfer of Intellectual Property Rights from Zomato to you.

## 7. REPRESENTATIONS AND WARRANTIES

- (i) You agree to use Weather Union only for the purposes as permitted under these T&C’s and in accordance with Applicable Laws
- (ii) You agree not to access (or attempt to access) Weather Union by any means other than through the interface that is provided by Zomato. You shall not use any deep-link, robot, spider or other automatic device, program, algorithm or methodology, or any similar or equivalent manual process, to access, acquire, copy or monitor any portion of Weather Union, or in any way reproduce or circumvent the navigational structure or presentation of Weather Union, materials or to obtain or attempt to obtain any materials, documents or information through any means not specifically made available through Weather Union.
- (iii) Without limiting the generality of these T&C’s, in using the Zomato Services, you specifically agree not to post or transmit any content or engage in any activity that, in our sole discretion:
- Is harmful, threatening, abusive, harassing, tortious, indecent, defamatory, discriminatory, vulgar, profane, obscene, libellous, hateful or otherwise objectionable, invasive of another's privacy, relating or encouraging money laundering or gambling.
  - Violates any third-party right, including, but not limited to, right of privacy, right of publicity, copyright, trademark, patent, trade secret, or any other intellectual property or proprietary rights.
  - Accuses others of illegal activity, or describes physical confrontations.
  - Is illegal, or violates any federal, state, or local law or regulation (for example, by disclosing or trading on inside information in violation of securities law).
  - Attempts to impersonate another person or entity.
  - Disguises or attempts to disguise the origin of your content, including but not limited to by:
    - (i) submitting your content under a false name or false pretences; or (ii) disguising or attempting to disguise the IP address from which your content is submitted.
  - Contains material that is not in English or, in the case of products or services provided in foreign languages, the language relevant to such products or services.
  - Falsely states, misrepresents, or conceals your affiliation with another person or entity.
  - Accesses or uses the account of another customer without permission.
  - Distributes computer viruses or other code, files, or programs that interrupt, destroy, or limit the functionality of any computer software or hardware or electronic communications equipment.
  - Interferes with, disrupts, or destroys the functionality or use of any features of the Zomato Services or the servers or networks connected to the Zomato Services.
  - "Hacks" or accesses without permission our proprietary or confidential records, records of

- another customer, or those of anyone else.
- Violates any contract or fiduciary relationship (for example, by disclosing proprietary or confidential information of your employer or client in breach of any employment, consulting, or non-disclosure agreement).
- Decompiles, reverse engineers, disassembles or otherwise attempts to derive source code from the Zomato Services.
- Removes, circumvents, disables, damages or otherwise interferes with security-related features, or features that enforce limitations on use of, the Zomato Services.
- Violates the restrictions in any robot exclusion headers on the Zomato Services, if any, or bypasses or circumvents other measures employed to prevent or limit access to the Zomato Services.
- Collects, accesses, or stores personal information about other customers of the Zomato Services.
- Is posted by a bot.
- Harms minors in any way.
- Threatens the unity, integrity, defense, security or sovereignty of India or of the country of use, friendly relations with foreign states, or public order or causes incitement to the commission of any cognizable offence or prevents investigation of any offence or is insulting any other nation.
- Modifies, copies, scrapes or crawls, displays, publishes, licenses, sells, rents, leases, lends, transfers or otherwise commercialize any rights to the Zomato Services or our content.
- Attempts to do any of the foregoing.
- is patently false and untrue, and is written or published in any form, with the intent to mislead or harass a person, entity or agency for financial gain or to cause any injury to any person.

## 8. SUSPENSION AND TERMINATION

- (i) **Suspension:** Zomato may suspend and/or temporarily deny access to Weather Union where any of your action(s) are or can be associated with breach of these T&C's.
- (ii) **Termination:**
- a. Without prejudice to the generality of the foregoing clause, Zomato reserves the right to terminate the Agreement with immediate effect for reasons as mentioned below:
    - Any breach of the terms of these T&Cs.
    - Any willful action or omission by You which may cause or causes legal or contractual liability for Zomato including but not limited to fraud, misconduct, gross negligence, and all other actions specifically prohibited under Applicable Law(s).
    - Indulging in spreading false or misinformation against Zomato through digital media, social networking sites, or any other form, with an intent to damage Zomato's brand and its goodwill.
  - b. You may terminate this Agreement by deleting Your account on Weather Union and thereby, not using the Zomato Services.
- (iii) In the event of suspension or termination, Zomato reserves the right to take appropriate legal actions that may be available under Applicable Law.

## 9. INDEMNIFICATION AND LIMITATION OF LIABILITY

- (i) You agree and undertake to indemnify and hold harmless Zomato its affiliates, successors, agents,

assigns, and each of their directors, officers, employees, associates, agents, and representatives from and against any losses, damages, liability, claims, costs, penalty and expenses (including, without limitation, reasonable attorneys' fees) incurred by reason of (a) any breach or alleged breach of your obligations, under these T&Cs; (b) any violation of Zomato's Policies; (c) any violation of Applicable Law(s); (d) any willful act or omission that causes or may cause harm to the reputation and goodwill of Zomato; (e) any claim of violation of Intellectual Property Rights of Zomato; (f) any misrepresentation with respect to the data or information provided by you in relation to the account; (g) any unauthorized disclosure or use of confidential information of Zomato; (h) any act of theft, fraud, negligence and misconduct by you; and (i) any loss or damage cause to the Device where You have opted for such Device to be installed at Your Location.

- (ii) In no event shall Zomato be liable to you or any third party for any special, incidental, indirect, consequential or punitive damages whatsoever, arising out of or in connection with your use of or access to Weather Union or Zomato Services.

## **10. DISPUTE RESOLUTION**

These T&C's shall be governed by the laws of India, for the time being in force and the courts of New Delhi shall have the exclusive jurisdiction to preside over matters arising hereunder.

## **11. MISCELLANEOUS**

- (i) Force Majeure: Zomato shall not have any liability under these T&C's or be deemed to be in breach of these T&Cs for any delays or failures in performance of these T&Cs which results from circumstances beyond the reasonable control of that party including but not limited to acts of God, pandemic, Government intervention, lockouts, fire, natural calamities, earthquake, tempest, flood, lighting, violence of any army or mob or enemies of the country.
- (ii) Assignment: You cannot assign or otherwise transfer the T&C's, or any rights granted hereunder to any third party. Zomato's rights under the T&C's are freely transferable by Zomato to its affiliates and any third party without the requirement of informing you or seeking your consent.

- (iii) Grievance Redressal Mechanism:
